RESOLUTION AWARDING CONTRACT FOR THE WEATHERFORD LANE AND HILLSIDE AVENUE PAVING PROJECT

At a special meeting of the Village Board of the Village of Millbrook, Dutchess County, New York, held at Village Hall, 35 Merritt Avenue, Millbrook, New York, on July 28, 2026.

WHEREAS

WHEREAS, The Village of Millbrook duly advertised for sealed bids for the Weatherford Lane and Hillside Avenue Paving Project in accordance with Section 103 of the General Municipal Law of the State of New York;

WHEREAS, Sealed bids were publicly opened on July 15, 2026, and five (5) bids were received;

WHEREAS, Following review of the bids, Peckham Road Corp., 172 Prospect Hill Road, Brewster, New York 10509, submitted the lowest responsive and responsible bid in the amount of Seventy-Eight Thousand Six Hundred Thirty-Seven Dollars and Fifty Cents (\$78,637.50);

WHEREAS, The Village Highway Superintendent has reviewed the bids and recommends that the contract be awarded to Peckham Road Corp. as the lowest responsive and responsible bidder.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village of Millbrook as follows:

Section 1. The Village Board hereby awards the contract for the Weatherford Lane and Hillside Avenue Paving Project to Peckham Road Corp. in the amount of \$78,637.50, subject to execution of the contract and submission of all required insurance certificates, bonds (if required), and other contract documents.

Section 2. The Mayor is hereby authorized to execute the contract and any documents necessary to complete the project on behalf of the Village of Millbrook.

Section 3. The cost of the project shall be paid through the NYS CHIPS reimbursement program.

Section 4. This Resolution shall take effect immediately.

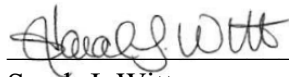
