Ordinance Amending Recycling Ordinance

The Town Board of the Town of Nepeuskun, at a duly-noticed Town Board Meeting, hereby ordains the following amendments to the Town of Nepeuskun's Recycling Ordinance:

Section 2. 14 1) is amended to read:

Lead acid batteries shall be disposed of at the Winnebago County Solid Waste located at 100 W. Co. Rd. Y, Oshkosh, WI or other WDNR approved recycling facility.

Section 2. 14 2) is amended to read:

Major appliances shall be disposed of at the Winnebago County Solid Waste located at 100 W. Co. Rd. Y, Oshkosh, WI or other WDNR approved recycling facility.

Section 2. 14 3) is amended to read:

Waste oil shall be disposed of at the Winnebago County Solid Waste located at 100 W. Co. Rd. Y, Oshkosh, WI or other WDNR approved recycling facility.

Section 2.15 1) is amended to read:

Aluminum containers shall be rinsed, stripped of labels and flattened.

Section 2.15 2) is amended to read:

Bi-metal containers shall be rinsed, stripped of labels and flattened

Section 2.15 3) is amended to read:

Corrugated Paper and Container board (cardboard) shall be dry, clean, and flattened. There shall be no shredded paper, and flattened cardboard shall be no bigger than 2' x 2'.

Section 2.15 6) is amended to read

Magazines shall be dry and clean (no shredded paper).

Section 2.15 7) is amended to read

Newspaper shall be dry and clean (no shredded paper).

Section 2.15 8) is amended to read

Office paper shall be dry and clean (no shredded paper).

Section 2.15 10) is amended to read:

Steel containers including tin cans shall be rinsed, stripped of labels and flattened.

Section 2.15 11) is amended to read:

Antifreeze, Electronics, Scrap Metal, Tires, Oil Products or Containers can be recycled at Winnebago County Solid Waste located at 100 W. Co. Rd. Y Oshkosh, WI or other WDNR approved recycling facility (charges may apply)

Section 2.15 13) is created to read:

All recycling must be removed from transportation containers or bags at recycling drop site (no plastic bags in dumpster)

All other provisions of the Town of Nepeuskun's Recycling Ordinance remain in full force and effect.

The Town Clerk and Town Attorney are hereby authorized and directed to take all action necessary to implement the terms of this Ordinance.
