# TOWN OF ROCKLAND, MANITOWOC COUNTY, WI ORDINANCE NO. 05-09-2022 ATU – UTV'S

AN ORDINANCE DESIGNATING ATV, UTV ROUTES AND REGULATING THE OPERATION OF THESE VEHICLES.

# **SECTION 1 - INTENT**

The Town of Rockland adopts the following all-terrain vehicle ordinance/route for the operation of all-terrain vehicles upon the roadways listed in Section III.

#### SECTION II - STATUTORY AUTHORITY

This ordinance is created pursuant to town authority under 23.33 (8) (b), Wisconsin Statutes.

The applicable provisions of 23.33, Wisconsin Statutes, regulating ATV/UTV operation are adopted

# **SECTION III - ROUTES**

All town roads are designated routes for ATV and UTV use within the township.

#### **SECTION IV - CONDITIONS**

As a condition for the use on town roads all operators will comply with the applicable provisions of 23.33, Wisconsin Statutes.

## SECTION V - REGISTRATION

In accordance with 23.33 (2) (c) 2, Wisconsin statutes, the ATV/UTV must be registered with the state and display a license plate on the rear of the vehicle.

#### SECTION VI - ENFORCEMENT

This ordinance shall be enforced by any local, county, or state law enforcement officer.

### SECTION VII - PENALTIES

All provisions of section 23.33 of Wisconsin Statutes describing and defining regulations with respect to ATV/UTV's of which the penalty is a forfeiture only are incorporated herein by reference. The penalty for violation of any provision of this chapter shall be a forfeiture as provided in section 23.33(13) of Wisconsin statutes together with the costs of prosecution.

# SECTION VIII - SEVERABILITY

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Town of Rockland would have passed the other provisions of this ordinance irrespective of whether one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons circumstances shall not be deemed affected.

#### SECTION IX - EFFECTIVE DATE.

This ordinance shall take effect 05-09-2022 upon passage and publication as required by law under s.60.80, Wis Stats.
