## Transient Occupancy Tax (TOT) Return Form

Every person providing transient lodging for remuneration in the Incorporated City of Weed must collect a tax of ten (10%) on the rent paid, unless that rent qualifies for exclusion or exemption. All allowable exclusions and exemptions must accompany this return form. This tax is due and payable to the City, before the 15th of the month following the close of the period. Payment becomes delinquent on the fifteenth (15th) day of the second month following the close of the reporting period. The Siskiyou County Tourism Improvement District assessment is due on or before the last day of the month following the close of the period, and payment becomes delinquent on the 1st day of the second month following the close of the period. For failure to pay by the amount prior to the due date, the lodging provider is subject to paying a penalty on the tax due. The initial penalty is ten percent (10%) of the amount due; further delinquency is subject to an additional monthly penalty for the first two months (20% max). The interest rate is one-half percent (0.5%) per month or fraction thereof. *Change of ownership, suspension, or disposal of business must be reported to us immediately.*
