DESCRIPTION OF WORK: The Shasta Valley Resource Conservation District (SVRCD) is acting as lead agency for this project, and the grantee is the City of Weed Fire Department. The SVRCD will administer the contract and serve as the primary contact during implementation.

This fuel mitigation project is located within and around the City of Weed in Siskiyou County, California. The treatment will protect habitable structures within the city of Weed and surrounding areas. The objective of this project is to provide immediate fuel mitigation to reduce fuel loading within the project area and to ensure a lasting effect on the community to reduce the fire hazard for many years after the project is complete. Funding for this project is provided by the California Department of Forestry and Fire Protection's Wildfire Prevention Program.

PROJECT TIMELINE:

- Contract award by March 15, 2026
- All activities must be completed by September 30, 2026

CONTRACTOR EXPERIENCE: This project requires that the contractor is experienced in performing forestry work. References for similar projects may be requested as determined by the SVRCD Project Manager.

CONTRACTOR OBLIGATIONS, LICENSING AND REGISTRATIONS: Contractor agrees to be bound by all the provisions of the California State Labor code regarding prevailing wages and shall monitor all contracts subject to reimbursement from this Agreement. The Contractor must be a Licensed Timber Operator for the State of California.

PRE-BID SITE VISIT: Contractors wishing to bid on this project may attend a pre-site visit on **February 12, 2026, at 9:00am**. Please contact Anna Parry at the email address above to confirm their attendance. Contractors will meet at the **Weed City Fire Department (128 Roseburg Pkwy, Weed, CA 96094)**. Representatives of the SVRCD and the City of Weed will be present to discuss the project.
