

TOWN OF SEVASTOPOL
Resolution No. 2022-06TB
Creating Emergency Medical Responders Committee

WHEREAS, the Town of Sevastopol previously resolved, pursuant to Resolution No. 02-02TB, to recognize the Sevastopol Emergency Medical Responders as an agency of the Town of Sevastopol, but not to form a committee, nor directly employ members of the Sevastopol Emergency Medical Responders as employees of the Town of Sevastopol;

AND WHEREAS, the Sevastopol Town Board has now determined that it would be beneficial to have an Emergency Medical Responders Committee reviewing, dealing with, and making recommendations regarding the use of Sevastopol Emergency Medical Responders as an agency to enhance the initial response to an emergency call located within the Town of Sevastopol;

AND WHEREAS, the Town of Sevastopol determines that it is in the best interest of the Town of Sevastopol and its citizens to have an Emergency Medical Responders Committee dealing with the Town of Sevastopol Emergency Medical matters and report to the Town Board of Supervisors;

NOW THEREFORE, BE IT RESOLVED that Resolution No. 02-02TB is rescinded;

NOW THEREFORE, BE IT FURTHER RESOLVED that the Sevastopol Town Board, Door County, Wisconsin does hereby create an Emergency Medical Responders Committee to consist of the Crew Chief of the Sevastopol Emergency Medical Responders, and one (1) or two (2) Town Supervisors appointed by the Town Chairman.

It Shall be the function of the Town Emergency Medical Responders Committee, amount other matters as it determines appropriate to:

- Maintain a current copy of the bylaws, rules, and regulations of the Sevastopol Emergency Medical Responders;
- Review and approve any proposed changes in the bylaws of the Sevastopol Emergency Medical Responders;
- Review the hiring of emergency medical responders by the Sevastopol Emergency Medical Responders;
- Oversee licensing, insurance, training, and ensure compliance with applicable laws;
- Report informational updates from the Sevastopol Emergency Medical Responders to the Town Board on a quarterly basis;
- Act consistent with Town Board requests as to other matters involving the Sevastopol Emergency Medical Responders.

The Town Board of Supervisors of the Town of Sevastopol does hereby continue to recognize the Sevastopol Emergency Medical Responders as an agency of the Town of Sevastopol. The members of the Sevastopol Emergency Medical Responders shall be considered employees of the Town of Sevastopol. The Town Board shall continue to work with the Sevastopol First Responders to assist and support their service to the health, safety and welfare of the public.

This resolution is effective immediately upon approval by the Town Board.


