

TOWN OF SEVASTOPOL
Ordinance No. 01-2002

**INTERSECTION OF PETERSON ROAD
AND WALKER ROAD**

The Town Board of the Town of Sevastopol, Door County, Wisconsin, does hereby ordain as follows:

Section 1: Purpose.

The Town Board may, when deemed necessary for the exercise of public safety, by ordinance, provide for the installation of stop signs and traffic control signs at intersections on highways over which it has exclusive jurisdiction as authorized by Wisconsin Statutes.

Section 2: Authority.

The Town Board establishes, by this ordinance, in compliance with Wis. Stats. Chapter 349.07, a traffic control stop sign to regulate, control, and enforce traffic regulations as prescribed by Wis. Stats. Chapter 346.46.

Section 3: Repeal of Ordinance.

Town of Sevastopol Ordinance No. 97-05, directing an all-way stop at the intersection of Walker Road and Peterson Road in the Town of Sevastopol is hereby repealed.

Section 4: Required Stop.

- A. Except when directed to proceed by a traffic officer or traffic control signal, every operator of a vehicle approaching the official stop sign traveling northbound upon Peterson Road at the intersection with Walker Road in the Town of Sevastopol shall cause any vehicle under his/her operation to stop before entering the intersection and shall yield the right of way to other vehicles which have entered or are approaching the intersection upon Walker Road.
- B. The provisions of Wis. Stats. Section 346.46 and any future amendments thereto are hereby incorporated and adopted by reference in order to make this ordinance in strict conformity with Wisconsin Statutes.

Section 5: Penalty.

The penalty for violation of this ordinance shall be as established by the "Uniform State Deposit Traffic Schedule" as periodically revised by the Wisconsin Judicial Conference.


Section 6: Enforcement.

This ordinance may be enforced by the issuance of a citation to any violator of said ordinance, by any sheriff or deputy sheriff of the County of Door, by any State of Wisconsin officer with police powers, or any duly appointed or elected law enforcement officer of the Town of Sevastopol.

Section 7: Effective Date.

This ordinance shall take effect upon passage and the day following its publication.


