

**TOWN OF SEVASTOPOL
ORDINANCE NO. 02-2001
Required Stops**

The Town Board of the Town of Sevastopol, Door County, Wisconsin, does ordain as follows:

Section 1 - Authority

The Town Board establishes, by this ordinance, and in compliance with Wis. Stats. Section 349.07 the following stop signs to regulate, control and enforce said signs as prescribed by Wis. Stats. Section 346.46.

Section 2 - Purpose

The Town Board may, when deemed necessary for the exercise of public safety, by resolution or ordinance, provide for the installation of stop signs and traffic signals at intersections on highways over which it has exclusive jurisdiction as authorized by Wisconsin Statutes.

Section 3 - Required Stops

- A. Except when directed to proceed by a traffic officer or traffic control signal, every operator of a vehicle approaching an official stop sign at the following intersections shall cause such vehicle to stop before entering the intersection and shall yield the right-of-way to other vehicles which have entered or are approaching the intersection upon a highway which is not controlled by an official stop sign or signal:
- (1) On Trillium Lane at its junction with Reynolds Road
 - (2) On Michelle Lane at its junction with Reynolds Road
 - (3) On Michelle Lane at its junction with Wildwood Lane
 - (4) On Wildwood Road at its junction with Reynolds Road
 - (5) On Wildwood Road at its junction with Carla Court
 - (6) On Dennis Road at its junction with Reynolds Road
 - (7) On Dennis Road at its junction with Carla Court
 - (8) On Edward Road at its junction with Reynolds Road
 - (9) On Edward Road at its junction with Elaine Drive
 - (10) On Elaine Drive at its junction with Dennis Drive
 - (11) On Reynolds Road at its junction with Townline Road
 - (12) On Townline Road at its junction with Reynolds Road
- B. The provisions of Wis. Stats. Section 346.46 and any future amendments thereto are hereby incorporated and adopted by reference in order to make this ordinance in strict conformity with state statutes.

Section 4 - Penalty


The penalty for violation of this ordinance shall be as established by the "Uniform State Traffic Deposit Schedule" as periodically revised by the Wisconsin Judicial Conference.

Section 5 - Enforcement

This ordinance may be enforced by issuance of a citation to any violator of said ordinance, by any sheriff or deputy sheriff of the County of Door, by any State of Wisconsin officer with police powers or any duly appointed or elected law enforcement officer of the Town of Sevastopol.

This ordinance shall take effect upon passage and the day following its publication.


