

**TOWN OF SEVASTOPOL  
ORDINANCE NO. 98-07**

An ordinance to revise the "launch fee" at Whitefish Bay Town Park and create penalties for failure to pay the appropriate launch fee.

THE TOWN BOARD OF THE TOWN OF SEVASTOPOL, DOOR COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

**Section 1 - Purpose:**

The purpose of this ordinance is to revise Ordinance No. 97-03 and to establish a revised schedule for launch fees at Whitefish Bay Town Park and to prescribe penalties for failure to pay the applicable launch fee.

**Section 2 - Authority:**

The Town Board establishes this ordinance in compliance with Wis. Stats. Section 60.22 (1), (2), and (3) to regulate the use and access to town park facilities.

**Section 3 - Launching Fees Established:**

No person shall use the Whitefish Bay Town Park boat ramp facility without first paying a daily launch fee in the sum of Five Dollars (\$5.00) to the dockmaster or by depositing it in the collection box provided. As an alternative to the daily launch fee, the Whitefish Bay Town Park boat ramp facility may be used by any person who has previously paid for and obtained either a resident annual pass for the sum of Twenty-five Dollars (\$25.00) or a non-resident annual pass for the sum of Thirty-five Dollars (\$35.00).

**Section 4 - Applicability:**

This ordinance shall apply to all trailered water craft which use the boat ramp facility. A separate fee shall be chargeable and due for each craft launched. There shall be no commercial ventures or water craft rental at the Whitefish Bay Town Park facility.

**Section 5 - Owner Liable for Violation:**

The owner of a vehicle involved in a violation of this ordinance shall be liable for the violation. It shall be no defense to a violation of this ordinance that the owner was not operating the vehicle at the time of the violation.

**Section 6 - Penalty Section:**

Failure to pay the fee prior to launch is a violation of this ordinance and shall be subject to a forfeiture of Fifty Dollars (\$50.00) plus court costs for each violation thereof.

**Section 7 - Enforcement:**

This ordinance may be enforced by the issuance of a citation to any violator of said ordinance, by any sheriff or deputy sheriff of the County of Door, by any State of Wisconsin officer with police powers, or any duly appointed or elected law enforcement officer of the Town of Sevastopol.

**Section 8 - Effective Date:**

This ordinance shall take effect the day after its passage and publication as prescribed by law.
