

**TOWN OF SEVASTOPOL
ORDINANCE NO. 04 - 2016
Traffic Ordinance Regulating Speed Limits on Certain Town
Roads**

Authority:

This regulatory ordinance is adopted by the Town board of the town of Sevastopol in Door County Wisconsin, pursuant to WI. State Statutes.

Purpose:

This ordinance is designed to allow the Door County Sheriff or Deputy Sheriff, State Officers or any other Wisconsin Officer with police power to regulate the speed limit of any vehicles on the public roads.

Regulation:

When the proper notification and procedures have been completed and proper signs have been erected after enactment of this ordinance, an operator shall not operate a motor vehicle faster than the posted speed limits on the following town roads:

This ordinance may be enforced by the issuance of a citation to any violator of this ordinance by any Sheriff or Deputy Sheriff of the County of Door, State of Wisconsin officer with police powers, or by the town constable of the Town of Sevastopol or any other duly employed law enforcement officer of the Town of Sevastopol.

Penalties:

Violation as currently provided and periodically amended by the judicial system of Wisconsin is also adopted by this ordinance.

Effective date:

When the majority of the Town of Sevastopol Town board adopted by this ordinance.
