

RESOLUTION APPOINTING TOWNSHIP MANAGER
TO CLAIM PROPERTY OF JACKSON TOWNSHIP
IN POSSESSION OF THE TREASURER OF THE
COMMONWEALTH OF PENNSYLVANIA

RESOLUTION NO. 10-95

The Board of Supervisors for Jackson Township, Cambria County, Pennsylvania wish to adopt a resolution authorizing the Township Manager to collect property of Jackson Township in the possession of the Treasurer of the Commonwealth of Pennsylvania.

WHEREAS, the Treasurer of the Commonwealth of Pennsylvania has certain property of Jackson Township in its possession; and

WHEREAS, the Board of Supervisors wish to obtain the Township's property from the Treasurer of the Commonwealth of Pennsylvania; and

WHEREAS, a Township Manager for Jackson Township was created by Ordinance No. 89, adopted by the Board of Supervisors on December 22, 1993;

WHEREAS, the Board of Supervisors want to authorize the Township Manager to collect the property of the Township that is currently possessed or in the future may be possessed by the Treasurer of the Commonwealth of Pennsylvania; and

NOW THEREFORE, based upon the foregoing recitals, the Board of Supervisors for the Jackson Township, Cambria County, Pennsylvania, adopt the following Resolution authorizing the Township Manager to collect property of Jackson Township in possession of Treasurer of the Commonwealth of Pennsylvania.

RESOLVED, the Treasurer of the Commonwealth of Pennsylvania has certain property of Jackson Township in its possession; and

RESOLVED FURTHER, that the Board of Supervisors want to obtain the Township's property from the Treasurer of the Commonwealth of Pennsylvania; and

RESOLVED FURTHER, a Township Manager for Jackson Township was created by Ordinance No. 89, adopted by the Board of Supervisors on December 22, 1993;

RESOLVED FURTHER, the Board of Supervisors authorize the Township Manager to collect the property of the Township that is currently possessed or in the future may be possessed by the Treasurer of the Commonwealth of Pennsylvania; and

RESOLVED FURTHER, that the following named person has been appointed to the position of Township Manager for Jackson Township, Cambria County, Pennsylvania and that they continue to hold this appointment at the present time, and that the signature appearing hereon is the genuine, original signature of the Township Manager:
