CHAPTER 11 ORDINANCE 2019-2

AN ORDINANCE TO REPEAL AND RECREATE ORDINANCE 2018-4 OF CHAPTER 11 OF THE TOWN OF TROY ORDINANCE BOOK, RELATED TO DOG LICENSE FEES

WHEREAS, the Town of Troy adopted certain dog license fees pursuant to Sections 174.05(1-5) and 174.07(1-3), Wisconsin Statutes, by Ordinance No. 2012-02, on or about May 9, 2012; and

WHEREAS, based upon a fee increase passed by Walworth County, the Town Board now intends to increase the dog license fees for the license year beginning in 2019; and

WHEREAS, the Town of Troy Town Board has determined that the fee will not exceed the total cost of all dog licensing, regulating and impounding activities for the previous year, less any refunds, and intends to establish a fee for un-neutered male dogs and un-spayed female dogs that is greater than the fee for neutered male dogs and spayed female dogs, pursuant to the requirements of Wisconsin Statutes Section 174.05(3).

NOW, THEREFORE, the Town Board of the Town of Troy, Walworth County, Wisconsin DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Town of Troy Ordinance No. 2018-4 entitled "Chapter 11. Dog License Fees" is hereby repealed.

SECTION 2: Chapter 11 of the Town of Troy Ordinance Book section entitled "Dog License Fees" is hereby created as follows: Pursuant to Sections 174.05(1-5) and 174.07(1-3), Wisconsin Statutes, a dog license fee on dogs within the Town of Troy, Walworth County, Wisconsin is authorized in the amounts shown in the table below:

<u>Type of Dog</u>	<u>Dog License Fee</u>
Un-neutered male	\$33.00
Un-spayed female	\$33.00
Neutered male	\$15.00
Spayed female	\$15.00

SECTION 3: SEVERABILITY.


The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 4: EFFECTIVE DATE.


This ordinance shall take effect beginning with the 2020 license year, following passage and posting or publication as provided by law.
