RESOLUTION NO. 2026-02

A RESOLUTION CHANGING THE 2026 BUDGET OF THE TOWN OF TROY, WALWORTH COUNTY, WISCONSIN, ADOPTED BY A TWO-THIRDS MAJORITY VOTE OF THE ENTIRE MEMBERSHIP OF THE TOWN BOARD UNDER WIS. STAT. § 65.90(5).

WHEREAS, the 2026 budget for Booth Lake Memorial Park was previously approved by the Town of East Troy, the Town of Troy, and the Village of East Troy and included a capital improvement for the removal of the old insulation, windows and siding, and installation of new insulation, windows and siding; and;

WHEREAS, with the work being completed by Booth Lake Memorial Park staff and other volunteers, the Booth Lake Memorial Park saved about \$25,000; and;

WHEREAS, the planned upgrade to the Booth Lake Memorial Park caretaker's house's envelope failed to recognize the lack of insulation in the attic compartment; and;

WHEREAS, the Booth Lake Park Board has voted in favor of Booth Lake Memorial Park RESOLUTION 2026-01 which requests that the budget be amended to include an additional \$6,600 contribution from the Municipalities for capital improvements; and;

WHEREAS, the additional capital improvement funding will be used to install insulation in the attic, at an approximate cost of \$600, and the purchase of deck building materials, with installation to be completed by Booth Lake Memorial Park staff and other volunteers at an approximate cost of \$6,000; and;

WHEREAS, the Booth Lake Park Board has requested that each municipality recognize the efficiency of costs and the lack of competitive bidding for the proposed capital improvements, by utilizing the efforts of the Booth Lake Memorial Park Board and employees to complete the proposed work; and;

WHEREAS, per the Booth Lake Memorial Park agreement municipality's share of capital improvements are equally split and would thereby result in an additional contribution of \$2,200.00 per Municipality,

NOW, THEREFORE, the Town Board of the Town of Troy, Walworth County does hereby resolve, and orders as follows:

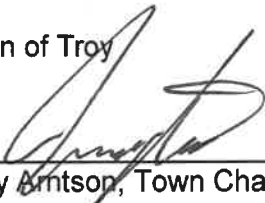
Section 1. That the sum of **\$2,200.00** is hereby transferred from the Town's General Fund Account to the **Conservation & Development, Booth Lake Memorial Park** Expense Account.

Section 2. That the sum of **\$2,200.00** is hereby transferred from the **Conservation & Development, Booth Lake Memorial Park** Expense Account and disbursed to the Booth Lake Memorial Park upon adoption and approval of this resolution.

Section 3. The Resolution shall be effective upon its adoption and approval.
