DOG LICENSES: Licenses may be paid for at the time of taxes. The fee is male or female **\$9.00**. Neutered or spayed animals **\$4.00**. A current certificate of vaccination for rabies must be shown for each dog licensed in our town. Dog Licenses **must be applied for prior to March 31, 2006 or a \$20.00 penalty per dog will be assessed. If you own rental property, it is your responsibility to inform your renters of this.**

FARMLAND PRESERVATION CERTIFICATES: Zoning Certificates will be issued for a **\$14.00** fee and can be gotten from the town treasurer. As last year you will only need a Zoning Certificate if you have had a change in your operation. If you need a new Zoning Certificate please call Greg Michels, Treasurer, as he will only prepare those that are needed.

BUILDING PERMITS: If the total cost of a project will be \$1000.00 or higher a building permit must be obtained. A **\$25.00** fee is charged for building improvements, with a **\$50.00** fee for new construction of homes or commercial buildings. You may obtain a permit by calling Pete Michels at 921-8156

FIRE SIGNS: A fee of \$50.00 will be assessed for new fire signs required for any new home or commercial construction. Pete Michels will be collecting this fee. 921-8156.

DRIVEWAY ACCESS/CULVERT PERMITS: The Town requires a completed application and \$25.00 permit review fee prior to installation of all new or reconstructed driveway access/culvert installations. Applications can be obtained from the Town Road Supervisor—Office-920-922-5282 or 920-948-7674

RECYCLING AND GARBAGE PICKUP

The Town of Lamartine will continue to implement the curbside pickup of recyclables and garbage. The cost of garbage pickup this year will be **\$97.00 per residence** and will be collected along with your property tax payments.

The garbage pickup will be on **THURSDAY**, on a **WEEKLY** basis. Recyclables will be picked up **once a month** on the **last Thursday of the month**. In the event that a pickup day falls on a holiday, pickup will be one day later—on Friday. To ensure pickup, bags and containers should be placed at the roadside by 6:00 am.

Garbage **must be placed in plastic bags**, if you place the secured bags in containers they are not to be larger than 32 gallons with outside handles and weighing less than 45 pounds.

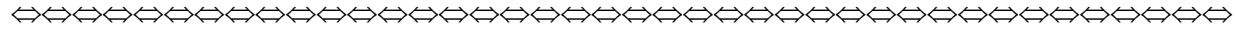
Recyclable items must be placed in light blue or clear bags.

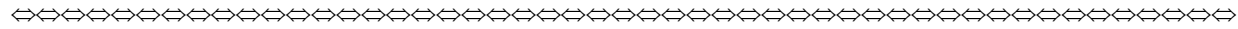
