Hydrant Flushing Notice – To Keep Water Flowing Clean & Clear!

The City of Eden Valley will be conducting routine hydrant flushing from October 6 to October 10.

This essential maintenance helps ensure high water quality and keeps our hydrants in top working condition for emergencies.

- You may notice **temporary discoloration** or a drop in water pressure—this is normal and safe.
- Run cold water for a few minutes if discoloration occurs.
- Avoid doing laundry during flushing in your area to prevent staining.

WINTER PARKING RESTRICTIONS:

NOVEMBER 1 - APRIL 1

No parking on any city streets between 2:30 am – 6:00 am.

VEHICLES WILL BE TOWED

KEEP SIDEWALKS SHOVELED. It is the responsibility of the property owner to shovel the sidewalk after each snow fall. (within 12 hours of snow fall). If it is not completed City will have it done at owners expense. §92.73

FIRE HYDRANTS: Remember to keep hydrants free of snow. This is for your safety and your neighbor's safety.

GARBAGE CONTAINERS: Don't place garbage cans in the street—they belong in the driveway.

Be **AWARE** of Snowplows and Snow removal equipment with flashing lights.

Be **COURTEOUS** to the snowplow drivers. They are doing their job; removing our snow so we can easily get around.

COMPOST SITE

- Place yard waste on correct piles
- Grass Clippings, leaves, Brush smaller than 4 inch in diameter.
- Take bags with you, do not leave them there
- Do not dump other items in compost. This is not a garbage site.

Fall Clean Up Dos and Don'ts

- DO: Remove weeds, long grass, and piles of brush.
- DO: Trim back trees and shrubs from around sidewalks and signs.
- DON'T: Sweep leaves or grass into the street
- DON'T: Dump or drain sump pump's into the sanitary sewer drains.

BUILDING PROJECTS FAQ's:

WHAT IS A ZONING PERMIT? It is a drawing of all buildings located on your parcel. It has all the setbacks from all property lines and all buildings. You will need to measure in your yard to get the setbacks.

HOW DO I KNOW IF I NEED A ZONING PERMIT?

Most building projects require a permit. Visit the website at ci.edenvalley.mn.us city code 150.171 site permits.

I AM JUST REPLACING MY SHED DO I NEED A PER-

MIT? Ask yourself—are you moving the shed (even a few inches)? Are you changing the size (even a few inches wider)? If you answered yes—you need a permit.

WHY DOES IT TAKE SO LONG TO GET THE PERMIT?

Permits must be reviewed, presented to the planning commission and then to the council. We need a completed application by the 2nd Thursday of the month to be approved by the first Wednesday of the following month.

Need help with utility bills this winter?

Apply for energy assistance—Electric and Heat

Applications accepted from Oct 1 to May 31 every year. Funds are available for renters or homeowners.

- Households who are at or below 50 percent of the state median income are eligible.
 - Size of grant is based on household size, income, fuel type and energy usage.
 - Federally funded through U.S. Department of Human Services.

Energy & Climate Resilience Plan Community Feedback

The City of Eden Valley is seeking your input on the proposed goals and actions for its Energy & Climate Resilience Plan.

An Energy and Climate Resilience Plan outlines ways to save energy and prepare for severe weather. It helps reduce costs, improve efficiency in buildings, and strengthen community readiness for events like storms, heat waves, or power outages.

The plan is organized into three key sectors: **City Operations, Residential, and Businesses & Organizations.** Each sector includes specific goals along with actions designed to help achieve them. **Please review each goal and its corresponding actions and share your feedback in the comments section.**

Goal 1: Become a Minnesota GreenStep City by completing program steps 1-2 by the end of year 1. Actions:

- 1.3 Educate staff and officials about GreenStep Cities.
- 1.4 Develop a webpage dedicated to GreenStep Cities and program achievements.

Goal 2: Install an electric vehicle (EV) charging station that will be accessible to the public and operational by the end of year 5.

Actions:

Goal 7: Design and implement a campaign to increase residential awareness about energy efficiency and renewable energy technologies, cost-savings and benefits.

Actions:

- 7.1 Create a dedicated webpage with resources on energy efficiency, renewable energy technologies and potential cost-savings.
- 7.2 Promote energy efficiency and renewable energy benefits through social media, newsletters, and community events.
- 7.3 Partner with United Community Action, Citizens Utility Board, or a similar organization to help residents prevent utility disconnections, access financial assistance, and better understand their utility bills.

- 8.3 Launch a webpage that hosts information about green infrastructure and stormwater BMPs such as raingardens, permeable pavers and cisterns.
- 8.4 Encourage residents to enroll in Adopt-A-Drain and help keep storm drains clear of debris to reduce local flooding and water pollution.
