3 **Sec. 58.66 Regulation of parking on Highway 42, Highway 57, and Village Streets.** ~~{Ord 312}~~

4 (a) Purpose. Pursuant to Wis. Stats. §§ 61.34(1) and 349.13(1), the purpose of this section is
5 to prohibit certain parking at any time in a certain area on State Highway 42, also known
6 as North Bay Shore Drive, State Highway 57, and prohibit long-term overnight parking on
7 South Bay Shore Drive and on all Village streets, ~~in~~ in order to reduce traffic congestion
8 throughout the village, and to provide for the health, safety and welfare of the Village
9 residents.

10 (b) Definitions. All of the definitions in Wis. Stats. § 340.01, as amended, are adopted by
11 reference in this section.

12 (1) 'Overnight' shall mean the period of time in which parking is prohibited on a public
13 street, and for purposes of this Chapter shall mean the period of time between the
14 hours of 2:00 AM and 7:00 AM.

15 (c) Prohibited parking.

16 (1) No person shall park, or suffer to be parked, at any time any boat trailer, motor
17 home, mobile home, camping trailer, or other motor vehicle in excess of 22 feet in
18 length on State Highway 42, also known as Bay Shore Drive, or on any public street
19 in the Village of Sister Bay.

20 (2) Except as provided for below, no motor vehicle, including trailers, shall be parked
21 overnight on North Bay Shore Dr.

22 (3) Except for safety reasons, overnight parking is prohibited on South Bay Shore Drive
23 or on any Village street. If a vehicle has been parked overnight, the owner shall
24 receive a written warning; if the vehicle is still parked on the street a second night,
25 a citation shall be issued.

26 (4) There shall be no parking along State Highway 57 from the south boundary of the
27 Village municipal limits, north a distance of 1500' parallel to the highway, on both
28 the east and west side of said highway.

29 (d) Exceptions. The exceptions provided by Wis. Stats. § 346.50, as amended, are incorporated
30 by reference in this section.

31 (e) Penalties.

32 (1) Any person violating this section may be required to forfeit a penalty per the most
33 recent fee schedule adopted by resolution by the Village Board. ~~not less than \$50~~
34 for the first offense and not less than \$75 for the second or subsequent offense
35 within one year.

36 (2) A separate offense shall be deemed committed on each day during or on which a
37 violation occurs or continues.

38 (f) Enforcement.

39 (1) This section may be enforced by the issuance of a citation to any violator of this
40 section by any sheriff or deputy sheriff of the county, by any state officer with police
41 powers or any other duly appointed law enforcement officer or designee of the
42 village.

1 (2) In the alternative, any forfeitures imposed by this section may be sued for and
2 recovered pursuant to Wis. Stats. Ch. 778 in the name of the village.

4 **SECTION 2. Available for Inspection.**

5 A copy of this ordinance shall be permanently on file and open to public inspection in the
6 Village Administration Office two weeks prior to its adoption and after its enactment.
7

8 **SECTION 3. Ordinances in Conflict.**

9 All other ordinances in conflict herewith be, and the same hereby are repealed.
10

11 **SECTION 4. Effective Date.**

12 This ordinance shall take effect and be in full force upon posting.
13

14 **SECTION 5. Severability.**

15 If a court of competent jurisdiction adjudges any section, clause, provision, or portion of this
16 ordinance unconstitutional or invalid, the remainder of this ordinance shall not be affected
17 thereby.
