

RESOLUTION NO. 2024-017

ADOPTING A SURPLUS PROPERTY POLICY

WHEREAS, to avoid the misuse of public funds, a policy should be adopted ensuring a universal understanding regarding what, when, and how surplus property is to be disposed of; and,

WHEREAS, such policy should not be cumbersome or time consuming, as currently dictated in the policy outlined in Resolution No. 388-091818, *Creating the Village of Sister Bay's Formal Policy Regarding The Disposition Or Sale Of Surplus Personal Property Or Equipment*, adopted September 18, 2018; and,

WHEREAS, after discussion at the August and October 2024 meetings of the Parks, Property & Streets Committee, the following revised policy has been proposed:

SURPLUS PROPERTY POLICY

1. Outdated or unused equipment and vehicle(s), which are not being traded-in towards the purchase of new equipment or vehicle(s), shall be offered at no charge to other village departments to determine if they can be used by those departments.
2. Outdated or unused equipment and vehicle(s) with an anticipated value under \$5000, which are not being traded-in towards the purchase of new equipment or vehicle(s), or being used by another village department, shall be offered to nonprofit organizations serving Sister Bay residents. The oversight committee to the department housing the outdated equipment and/or vehicle(s) shall determine, based on need and benefit, which nonprofit is to receive the donation. To solicit interest from nonprofit organizations, the Department Head shall promote the opportunity to acquire the equipment and/or vehicle(s) on the village website and any other platforms necessary to promote the donation opportunity. Interested recipients shall submit a letter of interest to the Department Head, who shall then forward all letters of interest to the oversight committee to determine who is awarded the outdated or unused equipment and vehicle(s). In the event no local nonprofit is interested in the offer, the Department Head shall be responsible for posting the property on a public surplus auction site.
3. Outdated or unused equipment and vehicles with an anticipated value of \$5000 or greater shall be advertised on a public surplus auction site commonly used by local government. If, after sixty (60) days, the equipment or vehicles do not sell at auction, they shall be offered to a nonprofit organization following the process outlined in 2 above.
4. Any proceeds from the auction of outdated or unused equipment and vehicle(s) shall be deposited in the Department's current year miscellaneous revenues account.

NOW THEREFORE BE IT RESOLVED, the Village Board of the Village of Sister Bay officially rescinds Resolution No. 388-091818, *Creating the Village of Sister Bay's Formal Policy Regarding The Disposition Or Sale Of Surplus Personal Property Or Equipment*, and any other resolutions or policies in conflict with the above, and adopts the above as the Village of Sister Bay official *Surplus Property Policy*.
