**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration the sufficiency and receipt of which is hereby acknowledged, the parties agree as follows:

- 1. The Permittee agrees that its heirs, successors, assigns, predecessor or successor entities or persons of any kind or nature, employees, contractors, subcontractors, officers and agents do hereby release, acquit and forever discharge the Town, its officers, agents and employees, from any and all liability whatsoever, whether joint or several, from all claims, actions, demands, causes of action, liabilities and obligations of whatever nature (collectively, the "Claims"), whether now known or hereafter made known, anticipated or unanticipated, choate or inchoate, whether arising by tort, contract or otherwise, at law or in equity, which the Permittee might have or raise that are related to this Agreement or the activities permitted pursuant to this Ordinance except to the extent that such Claims result from Town's negligence or willful misconduct.
- 2. The Permittee further understands that by signing this Agreement the Permittee agrees on behalf of himself/herself or its heirs, successors, assigns, predecessor or successor entities or persons of any kind or nature, employees, contractors, subcontractors, officers and agents (collectively, the

"Permittees") assume all risk of injury, death or property damages that may be suffered in connection with the activities permitted hereunder; except to the extent that such Claims result from Town's negligence; and that the Permittee will save, protect, hold harmless, indemnify and defend the Town against any legal actions or other claims for damages arising from the Permittee's actions hereunder. This duty to defend and indemnify includes, but is not limited to, any third-party claims brought against the Town related in any way to the activities herein, except as to the Town's negligence or willful misconduct.
