IMMEDIATELY FOLLOWING THE SPECIAL TOWN MEETING, A REGULAR MEETING OF THE PLOVER TOWN BOARD WILL BE HELD WHICH WILL INCLUDE DISCUSSION AND ADOPTION OF THE YEAR 2023 TOWN OF PLOVER BUDGET.
