IMMEDIATELY FOLLOWING THE SPECIAL TOWN MEETING, A REGULAR MEETING OF THE PLOVER TOWN BOARD WILL BE HELD WHICH MAY INCLUDE DISCUSSION AND ADOPTION OF THE YEAR 2025 TOWN OF PLOVER BUDGET.
