Violators of Township Ordinance No. 2020-03, Chapter 129, as amended, are subject to fines and/or arrest and/or revocation of permits with no refund of fees. Solicitation is only permitted between the hours of 8:00 a.m. and 8:00 p.m., Monday through Saturday. Permits are non-transferable and any individual denied a permit may appeal to the West Brandywine Township Board of Supervisors, pursuant to section 129-8 of Chapter 129 of West Brandywine Township Code.
