RESOLUTION# 09-2025

ADOPTION OF THE RECOMMENDED 2025-2045 COMPREHENSIVE PLAN AS PREPARED BY THE PLAN COMMISSION

WHEREAS, the City Council of Hillsboro assigned the Plan Commission to prepare an update to the City's Comprehensive Plan, previously adopted in 2003 and most recently updated in 2016 for the City of Hillsboro; and

WHEREAS, the Plan Commission met numerous times to prepare and review the draft City of Hillsboro 2025-2045 Comprehensive Plan; and

WHEREAS, members of the public were invited to participate in the planning process through regular monthly Plan Commission meetings; and

WHEREAS, the City of Hillsboro Plan Commission has reviewed the recommended City of Hillsboro 2025-2045 Comprehensive Plan at a regular meeting; and

WHEREAS, members of the public, adjacent local governmental units, and Vernon County will be given a 30-day review and comment period prior to the public hearing, which will be conducted by the Committee of the Whole for the City of Hillsboro 2025-2045 Comprehensive Plan; and

WHEREAS, after said public hearing, the City Council will decide whether to adopt by ordinance the Comprehensive Plan; and

WHEREAS, the Comprehensive Plan may be used as the basis for, among other things, official mapping, local subdivision regulations, general zoning ordinances, shoreland/wetland zoning, and as a guide for approving or disapproving actions affecting growth and development within the jurisdiction of the City of Hillsboro; and

WHEREAS, this City of Hillsboro 2025-2045 Comprehensive Plan may from time to time be amended, extended, or added to in greater detail.

NOW, THEREFORE, BE IT RESOLVED, that the City of Hillsboro Plan Commission recommends adoption of said City of Hillsboro 2025-2045 Comprehensive Plan by the City Council by ordinance, after the 30-day public review and comment period and public hearing.

ORDINANCE # 3-2025 City of Hillsboro 2045 Comprehensive Plan Ordinance

WHEREAS, the City of Hillsboro's current Comprehensive Plan was adopted in 2003 and amended in 2016; and

WHEREAS, Wisconsin State Statute 66.1001 requires municipalities to update their comprehensive plan every 10 years; and

WHEREAS, the Common Council adopted written procedures designed to foster public participation in every stage of the preparation of an updated comprehensive plan; and

WHEREAS, the Common Council appointed a City Plan Commission to update the City's comprehensive plan; and

WHEREAS, the Plan Commission met multiple times to create and then held a public hearing on October 20, 2025 to consider the City of Hillsboro 2045 Comprehensive Plan ("Plan"), which is intended to guide decisions and actions affecting the City's budgets, ordinances, and growth over the next 20 years; and

WHEREAS, the Plan Commission, by a majority vote of the entire commission, recorded in its official minutes, adopted a resolution on October 20, 2025 recommending the City Council adopt the Plan by ordinance;

NOW, THEREFORE BE IT ORDAINED, that the Common Council of the City of Hillsboro formally adopts the City of Hillsboro 2045 Comprehensive Plan under Wis. Stat. 66.1001 (4)(c).

This ordinance is effective on publication or posting.

An electronic copy of the City of Hillsboro 2045 Comprehensive Plan Ordinance and the Plan—or notification on how to view/download the Plan—will be disseminated to neighboring jurisdictions and appropriate government agencies under Wis. Stat. 66.1001(4)(b).






Q2 How long have you lived in or near Hillsboro?

Q5 Do you rent or own your current primary residence?




Q6 If you were to move in the next 5 years, would you prefer to own or rent your housing?


Q7 If you were to move in the next five years, what form of residence would you consider? (check all that apply)

Q13 Which of the following would improve your ability to work remotely from Hillsboro? (check all that apply)








Q20 How often do you visit the local businesses of the City?









Q25 What gender do you identify with?








Q28 How many members of your household are under the age of 18?




