### **Dates to Remember**

#### **2<sup>nd</sup> and 4<sup>th</sup> Mondays Each Month** –

*Town Board meets at 6:30pm in most cases except when the Portage County Unit of the Wisconsin Towns Association meets the same night.*

**Jan. 1 to May 31** – Burning Permits required once ground is no longer completely snow covered. Call 1-888-WISBURN or get your annual permit at [www.dnr.wi.gov/wisburn](http://www.dnr.wi.gov/wisburn)

**January 31<sup>st</sup>** – Walk-in 2015 Dog licenses for all dogs over the age of 5 months are available at the Town Hall from 8:30am to 11:00am (today only). Please bring a current rabies certificate, proof of neuter or spay, and \$8 per spayed or neutered dog or \$18 per non-spayed or neutered dog.

**February 17<sup>th</sup>** – Primary Election, if needed, for State Justice of the Supreme Court, Stockton Municipal Offices and local School Board.

**March 1<sup>st</sup>** – Temporary Class B Weight Limits went into effect on March 24<sup>th</sup> last year. Get your heavy hauling done before the weight limits are imposed again. Call Chairman Mike Bronk or Road Crew Foreman Jeff Herman for exemption requests.

**March 14<sup>th</sup>** – Walk-in Rabies Clinic and Dog Licensing at the Stockton Town Hall from 9:00am to 12:00pm.

**April 7<sup>th</sup>** – Spring Election.

### **Frequently Asked Questions**

#### **The Snow Plow Hit My Mailbox...**

*Mailboxes should be on breakaway posts (no larger than 4" x 4") located at least 3 to 4 feet from the pavement with 42 to 48 inches of clearance from the ground to the bottom of the mailbox. We will replace mailboxes we damage with mailboxes of similar value as long as these guidelines are followed. Contact the US Postal Service for more info.*

#### **What is the Long-range Plan for Highway 10 between Amherst & I-39?**

*The WisDOT states that "while there are currently no plans to construct a new location for Hwy 10, the identification and mapping of the future location is part of routine long-range planning. A public hearing is being planned for this summer so the future location can be mapped and recorded. WisDOT will continue to monitor traffic and safety conditions along the existing US 10 corridor and will not proceed with any plans to relocate US 10 until the current alignment can no longer safely handle regional and local traffic. The department's priority is to ensure that the current location of US 10 can operate safely and efficiently in its current location." Look for more in the April newsletter. If you are plowing snow across the road, clean the road immediately for safe driving for others. Otherwise, you will be notified that you are breaking the law according to Wis. Stats 86.01. If the town needs to clean up after you, you will be billed for the work. The 2nd warning will include a fine of **\$50.00**.

*ALL DOGS OVER THE AGE OF 5 MONTHS MUST BE LICENSED IN THE TOWN OF STOCKTON*

You must send or bring a copy of the current rabies certificate for each dog you are licensing, as required under WI SS #174-05. Note: A late fee of \$5.00 per dog will be assessed after April 1<sup>st</sup>.

**Please include the following items:**

- Current rabies certificate
- Proof of neuter or spay
- License fees (Check made out to: *Town of Stockton*)
- Self-addressed stamped envelope for license return**

# GUIDE TO RECYCLING


(Please Empty and Rinse All Containers)




**ALUMINUM CANS** - Includes used beverage cans only. No foil or food containers.



**CONTAINER GLASS** – Includes clear, brown, green and blue container glass only. Glass should be clean. Glass **DOES NOT INCLUDE** ceramic cups, dishes, ovenware, plate glass, safety and window glass, heat-resistant glass such as Pyrex, light bulbs, mirrors, or lead-based glass such as crystal.



**PLASTIC CONTAINERS** – Includes only food and beverage bottles and containers marked with the #1 through #7 recycling emblem like cat litter containers, ice cream pails, 5-gallon pails, medicine/pill containers, bakery containers, flower pots or trays, yogurt or cottage cheese containers, cups & tubs, clear and rigid clam shell packaging. Includes aseptic packaging such as juice boxes, ice cream, soy milk and soup broth containers. **DOES NOT INCLUDE** motor oil bottles, plastic bags, Styrofoam cups, egg cartons, containers and packaging peanuts.



**TIN CANS** – Includes metal cans, bi-metal cans and steel containers which must be clean. Cut out end can be secured inside can.



**MIXED PAPER PRODUCTS** – Includes all grades of papers including: white, colored, ledger, shiny, coated, carbonless, envelopes – including windowed, labeled and kraft; newspapers, magazines, phone books, computer printout paper, glued pads and tablets, file folders, post-it notes, spiral notebooks, cereal boxes, shoe boxes, paper grocery bags, beverage cartons. Can include paper clips and staples. **DOES NOT INCLUDE** waxed paper, hand towels, napkins or paper plates.



**CORRUGATED CARDBOARD** – Includes clean corrugated cardboard only. **DOES NOT INCLUDE** waxed cardboard. Cardboard must be flattened and bundled in bundles not more than twelve (12) inches high by twenty-four (24) inches wide and thirty-six (36) inches long.

*ALL paper products should be placed in a paper bag or bundled*



**Not Acceptable Items (place in trash)**

- ◆ Plastic Bags & Film
- ◆ Aluminum Foil
- ◆ Motor Oil Containers
- ◆ Pesticide or Herbicide Containers
- ◆ Empty Paint Cans
- ◆ #1 Brown Plastic Bottles
- ◆ Styrofoam or Microwave Containers
- ◆ Aerosol Cans
- ◆ CD cases & Vinyl Siding
