#### **Dates to Remember**

**November 4**<sup>th</sup> - Last day to vote in-person Absentee in the Clerk's Office for the November 9<sup>th</sup> General Election. No in-person registration and/or absentee voting may be conducted after 5:00 pm on the last Friday prior to the Election.

**November 6<sup>th</sup>** - Daylight Saving Time ends at 2 a.m. on Sunday, November 6, 2016. Remember to turn your clock back (fall back) one hour. It's also a good time to change the batteries in your smoke detectors!

**November 9<sup>th</sup>** - Election Day! Town of Stockton residents are encouraged to vote at the Town Hall. Polls are open from 7:00 am – 8:00 pm.

**November 17**<sup>th</sup> – A public hearing immediately followed by a Meeting of the Electorate convenes at 6:30 pm to consider the proposed 2017 Town of Stockton budget. The public hearing and the Meeting of Electorate will take place at the Town Hall, 7252 6<sup>th</sup> Street, Custer.

**November 24th** – The Town of Stockton Clerk's Office will be closed in observance of Thanksgiving.



#### **Town Board Meetings**

The Town of Stockton Board meets the second and fourth Mondays of the each month at 6:30 pm.

#### **Plan Commission Meetings**

The Town of Stockton Plan Commission meets the first Wednesday of each month at 7:00 pm.

#### **Fire Department Meetings**

The Town of Stockton Fire Department members meet on the second and fourth Wednesday of each month at 6:30 pm.



**Tuesday, November 8<sup>th</sup>, 2016** is the Fall General Election which includes a number of Congressional, Legislative, State and County offices as well as the Presidential Election.

Polls will be open from 7:00 am – 8:00 pm. We're doing a lot of preparation in advance to make the voting experience as smooth and efficient as possible.

First, **please be patient**. There are a lot more people expected to vote in this election than other elections simply due to the presidential candidates on the ballot. We will have election personnel trained and available the entire day to guide you through the process.

Second, **photo ID** is **required**. The easiest from of photo ID is a Wisconsin Driver's License or Wisconsin State Issued ID card. There are a number of acceptable photo IDs if you don't have a Wisconsin Driver's License. Contact the Clerk for more information.

Next, if you are a first time voter, new to the area, have an address change or a name change; you will need to fill out the Wisconsin Voter Registration Application. You will need a photo ID as well as proof of residence. Contact the Clerk for further details.

If you prefer to vote Absentee, you may do so.
You don't need a reason, it's your right. To vote absentee, contact the Clerk to obtain an Absentee Ballot Application. Deadline to vote Absentee in the Clerk's Office is Friday, November 4<sup>th</sup>. The Clerk's Office will be open on November 4<sup>th</sup> from 8:00 am – 5:00 pm to accommodate Absentee requests.
All mailed absentee ballots must be received via USPS by 8pm Election Day in order to be counted.

#### **Town of Stockton Park Update**

Town of Stockton residents can look forward to many happy gatherings with family and friends at the new Town of Stockton Park, located at 3333 Custer Road.

Frisbee lovers young and old are already enjoying the 9-hole disc golf course. Situated among a variety of oaks and evergreens on rolling hills, the course offers challenge and relaxing recreation. It is even reported that Jim Dodge, who is 82, can handle #8 pretty well!

In July, a dozen volunteers helped the Township crew and professional representatives install first-rate playground equipment at the site. This 40x70 play area boasts a variety of climbing bars, slides and swings. A huge thank you to Wimme Gravel for donating the ground cover for the playground area!

Located among flourishing trees planted several years ago are several tables and charcoal grills. This area has easy access to a clean porta-potty and the newly paved parking lot. An attractive shelter will be added next summer.

Brightening the north bank of the park is a splendid variety of annual and perennial flowers. They also highlight a lengthy walking trail. Several benches on this hill invite walkers to sit and enjoy a pleasing view of our expansive park and surrounding woods and fields.

And yes, the coming winter months may even seem less bleak to those who enjoy the well-maintained ice rink and sledding hills. Truly our community can be pleased to provide such a quality recreation space for all ages.

#### **Fall/Winter Reminders**

Please remember that garbage carts and recycling containers should be placed out for pick up on the designated days. Ensure that you are not placing carts and/or containers in the road way as this creates problems for both pedestrians and vehicle traffic. In addition, please be sure you are being mindful of the Road Right of Way. It is illegal to dump grass clippings, brush and/or other material in to this area.

As winter approaches, we'd like to remind residents of our policy for snowplowing which is to keep the main routes open, open secondary routes and then open the remaining minor roads. Our fleet of three trucks is maintained and operated by Town personnel. The snowplowing of private driveways is not done, except in emergency situations.

Also as a reminder, plowing snow into the road or across the road and into the opposite ditch is hazardous. This creates bumps, ice dams, or hazardous piles of snow on the road and causes snow to blow onto the road. Once driven on or frozen, these bumps are extremely difficult to plow and may cause a passing vehicle to lose control. If you are plowing snow across the road, clean the road immediately for safe driving for others. Otherwise, you will be notified that you are breaking the law according to Wis. Statutes 86.01. If the town needs to clean up after you, you will be billed for the work. A 2nd warning will include a fine of \$50.00 from the Town of Stockton as stated in the Town Snow Removal Ordinance O-08-01.

## **Adopt A Road**

Have you ever wondered how the Adopt-A-Road clean up works? Are you interested in volunteering but not sure who to contact or how to get started? It's rather simple! Talk it over with your club, friends, neighbors, family, etc. and pick a leader from your group, then contact Lauri Novotny, our Town Clerk, at 715-592-4712 and confirm that the roadway you wish to "adopt" is available. We generally ask for a mile stretch of road but if you prefer a longer stretch, that's fine, too!

The clerk will supply you with an application and a Consent/Release agreement for each volunteer to sign. The Town will supply a sign with the group name or acronym to be displayed on the assigned area. The Town will supply you with clean-up supplies that include a safety vest, gloves, trash bags and safety signs. After you've participated in a clean-up event, contact the Town Clerk or our Town Garage to let them know where you have left the trash bags (specifically on what road) and the road crew will pick them up and dispose of them. We ask that your group clean up the adopted road twice a year, usually in May and October, but you may perform the clean up duties at any time and more frequently if you so desire.
