Free Nitrate Screening

Nitrate is the most widespread groundwater contaminant in Portage County. There are a number of potential health risks associated with elevated nitrate levels in drinking water, but it can be especially dangerous for unborn children and infants younger than six months.

It is important for private well owners to understand the current status of their drinking water quality, thus drinking water should be tested annually.

Private well owners are invited to bring in a water sample from their drinking water well to have it screened for nitrates, one of the most common groundwater contaminants in Portage County, free of charge.

When: September 11th, 2019

What to Bring: ½ Cup Water sample in a clean container with a lid

How to collect your sample:

1. Identify a source that is not connected to a treatment device. An outside faucet works best.
2. Locate a clean container with a lid to collect the water sample. Label the outside with your name or address
3. Allow the water to run five-10 minutes before collecting your sample.
4. Fill the container with about a half cup of water.

Samples are analyzed on the spot and the process only takes a few minutes. Results will be given directly to the homeowner.

Town Board Meetings: The Town of Stockton Board meets the second and fourth Mondays of each month at 6:30 pm.

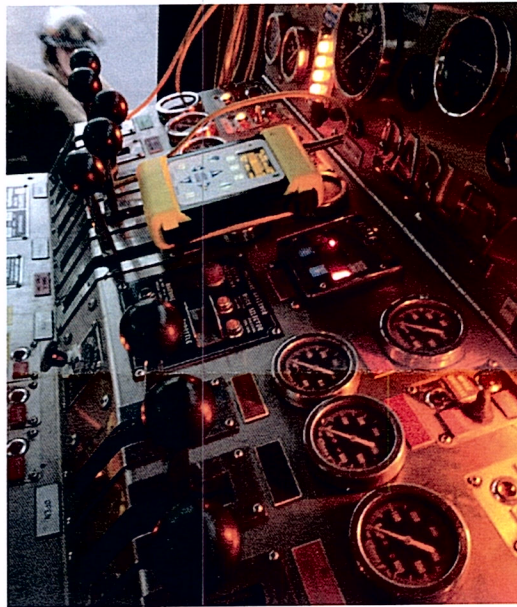
Plan Commission Meetings: The Town of Stockton Plan Commission meets the first Wednesday of each month at 6:30 pm.
