## LOCAL LAW NO, 1 of 1983

A LOCAL LAW PROVIDING FOR THE CONDUCT OF GAMES OF CHANCE IN THE TOWN OF NEWPORT

BE IT ENACTED by the Town Board of the Town of Newport as follows:

Section 1 -  $\overline{\text{TITLE}}$ : This LOCAL LAW shall be known as the GAMES OF CHANCE LAW for the Town of Newport.

Section 2 - <u>DEFINITIONS</u>: "Authorized Organization" shall mean an authorized organization as defined in Article 4 of Section 186 of The General Municipal Law.
"Games of Chance" shall mean a game of chance as defined in Article 3 of Section 186 of The General Municipal Law.

Section 3 - GAMES OF CHANCE AUTHORIZED: Authorized organizations, may upon obtaining a license from the Town Clerk, conduct Games of Chance within the Town of Newport as provided in Article 9A of the General Municipal Law and as provided further in this Local Law. Such Games of Chance shall be conducted in accordance with the Laws of the State of New York and with the Rules and regulations adopted by the New York State Racing and Wagering Board and pursuant to this Local Law.

Section 4 -  $\overline{\text{RESTRICTIONS:}}$  The conduct of Games of Chance shall be subject to the restrictions imposed by Section 189 of the General Municipal Law.

Section 5 - SUNDAY GAMES: Games of Chance may be conducted on Sunday pursuant to this Local Law No. 1. However, no Games of Chance shall be conducted on Easter Sunday, Christmas Day, or News Years Eve.

## RIDER

Section 6 - ENFORCEMENT: The sheriff of the County of Herkimer shall exercise control over and supervision of all Games of Chance conducted duly under authorized license. The Sheriff shall have all powers and duties set forth in and for the Enforcement of Article 9A of the General Municipal Law.

Section 7 - EFFECTIVE DATE: This Local Law No. 1 shall take effect immediately upon filing with the Office of the Secretary of State following its approval by the Majority of the Qualified Voters of the Town of Newport voting on a proposition thereof, at the General Election held pursuant to the provisions of Section 24 of the Municipal Home Rule Law.
