Section 1. No civil action shall be maintained against the Tow of Newport or the Town Superintendent of Highways for damages or injuries to person or property (including those arising from the operation of snowmobiles) sustained by reason of any Highway, Bridge, Culvert, Highway Marking, Sign or Device or any property owned, operated or maintained by the Town being defective, out of repair, unsafe, dangerous or obstructed unless written notice of such defective, unsafe, dangerous or obstructed condition of such highway, bridge, culvert, highway marking, sign or device or any other property owned, operated or maintained by the Town was actually given to the Town Clerk or Town Superintendent of Highways, and there was a failure or nelgect within a reasonable time after the giving of such notice to repair or remove the defect, danger or obstruction complained of; but no such action shall be maintained for damages or injuries to person or property sustained solely in consequence of the existance of snow or ice upon any highway, bridge or culvert, unless written notice thereof, specifying the particular place, was actually given to the Town Clerk or Town Superintendent of Highways and there was a failure or neglect to cause such snow or ice to be removed, or to make the place otherwise resonably safe within a resonable time after the receipt of such notice.

Section 2. The Town Superintendent of Highways shall transmit in writing to the Town Clerk within five days after the receipt thereof all written notices received by him pursuant to this Local Law and subdivision 2 of Section 65-a of the Town Law. The Town Clerk shall cause all written notices

Section 3. This Local Law shall supercede in its application to the Town of Newport subdivision 1 and 3 of section 65-a of the Town Law.

Section 4. This Local Law shall take effect immediately upon its filing in the office of the Secretary of State in accordance with the provisions of Section 27 of the Municipal Home Rule Law.
