A Local Law to give the Newport Planning Board Sole Authority to Approve and Grant Special Use Permits Without any Reference to the Town Board

BE IT ENACTED, by the Town Board of the Town of Newport, County of Herkimer, State of New York, as follows:

Section 1. Legislative Intent

It is the intent of this local law to give the Newport Planning Board sole authority to approve and grant Special Use Permits in accordance with the provisions of the Newport Zoning Ordinance.

Section 2. Authority

This local law is adopted pursuant to Section 10 of the Municipal Home Rule Law and Section 274-b of the Town Law of the State of New York.

Section 3. <u>Authority to Approve and Grant Special Use Permits</u>
