Tier 2: For Signs from 21 to 99 S.F.

\$50.00 Base Fee

Add Tier 2 Surcharge: plus \$3.00 per S.F. over 20 S.F. (range: \$3.00 - \$237.00)

Add Zoning Officer Review - \$105.00

Tier 3: For Signs from 100 S.F. to 199 S.F.

\$50.00 Base Fee

Add Tier 2 Surcharge: \$237.00

Add Tier 3 Surcharge: plus \$3.50/S.F. over 99 S.F.: (Range \$3.50 - \$346.50)

Add Zoning Officer Review - \$105.00

<u>Tier 4: For Signs from 200 – 300 S.F.</u>
