KEY UPDATES

2025 City Priorities: During my brief speech at NNO, I outlined three key imperatives for our city: 1) Financial Stability, 2) Safe & Reliable Infrastructure, and 3) People & Process. Over the past six years, we've overcome our financial challenges by securing funding for our infrastructure projects while minimizing tax impacts. With our financial and infrastructure stabilized, I'm excited to shift our focus inward to People & Process – enhancing internal operations and fostering greater community involvement in leadership roles and essential functions that are vital to the long-term success of our city.

City Water Hookup: We want to make it as easy as possible for residents to connect to city water. The City attempted to organize a group bid and turnkey program, but the house-to-house variations made it challenging to receive discounted group pricing. As a result, it will be more cost-effective for each homeowner to manage this process independently. However, we are here to support you every step of the way. Recently one resident reached out to the mayor after a raccoon scratched a hole through their roof. Evicting raccoons is outside of this City's responsibility. Wild Life Management needs be contacted for that.

Please be advised that raccoons are capable of making a home out of any outlying and unattended structures. Last winter alone, two outlying structures homed raccoons. The city enforced the owners to fix the structures so this would not continue.

The city requests homeowners to check any outlying structures on your property for raccoons, or any structures raccoons could potentially use as home. Look for any openings in garages, sheds or boat houses and board them up.

And, please, don't feed the raccoons!
