#### Medicine Lake Cares! Fundraiser for Second Harvest Heartland by Paul Samson

Just a "heads up" that for the Sixth Time, the City of Medicine Lake Community Club is organizing a fundraiser, Medicine Lake Cares!, to assist Second Harvest to provide food for the hungry in our communities. The fundraiser will run from November 15 to December 15. A new twist this year is "match the match". Several residents have agreed to match the first \$12,500 raised to achieve our total community goal or \$25,000. ### City Water Connection Information by Paul Samson

I'd like to share information I have gathered regarding connecting your home to the city's mainline water system. I've been advised to mention that while I believe the information below is accurate, you need to personally verify all this information prior to selecting a contractor because you alone (not me or the City) are responsible for hiring a contractor and for any work performed by a contractor. I have gotten information/bids from the following:

**Note:** In most cases the contractor quote includes excavating a hole to access the curb stop, connecting the water line to the curb stop, running the water line from the curb stop into the home, connecting the water line to the water meter, making the plumbing connections from the meter for whole house city water use, disconnecting your well from the domestic service lines, reconnecting your existing well to outside spigots and patching any damaged concrete where the water line comes into house. The quote generally does not include all the approximately \$5000 in fees associated with connecting to City water. Contractors can install the water line and meter now and cap it so you can continue to use your existing well if you choose.

Costs: I hesitate to give cost estimates, because every home and every install is unique. But from what I've heard, the best contractor quotes for complete water installation start at \$6500 for the most simple/shortest runs to \$8500 for simple/longer run installs plus fees. With the approx. \$5000 in

fees, the "all-in" costs in this example would be approx. \$11,500 to \$13,500. I have not heard of a quote for a more complicated/longer run install. If your home has an unusually long run, severe elevation changes or other unique property attributes, expect to pay more (maybe substantially). And pricing is dynamic. If a contractor is busy, expect their quote to be more.

Some of the other contractors listed are viable options. (Get quotes because pricing is dynamic)

Highview Plumbing: (Primarily plumbers that sub out the lateral drilling) Highview has completed (some partially) around 10 of the initial installs in Medicine Lake. A resident told me Highview is very professional and they are pleased with the workmanship. And because Highview are plumbers, they provided valuable information to the driller to optimize where the waterline should come into the house. I was never able to get a quote from Highview. I know they are currently very busy and that may change. Based upon information I have received, if Highview would have given me a quote, it most likely would have been substantially more than J. P. Schmitz.

**J. P. Schmitz & Sons.** (Primarily lateral drillers that sub out the plumbing) Based upon cost, service, quality of work, and availability, I am going with J. P. Schmitz & Sons. John Schmitz is the owner of this family run company. John does all the emergency water service work for Plymouth. I have personally met with John and was impressed. J. P. Schmitz recently did 3 installs on 15th Ave North and the property owners are happy. John's typical install will be an upgraded 1 1/4 " CTS pipe (the same size as 1" ID iron pipe). John's claims their directional boring equipment can hit an area within a 1 foot target into your basement or crawl space. John also felt that if work is done now, most homes will not require dewatering. He is currently scheduling 2-3 weeks out but you may be able to get on the schedule when he does another home in your neighborhood. (He has pending installs on Kaiser and Peninsula Road). In some cases, the boring will be done one day and the plumbing hookup in the house the next day. John will also reconnect the existing well pipes to outside spigots. The quote I received did not include any of the approx. \$5000 in fees.

In some cases, Highview quotes have included all fees except the \$4336 City fees.) say in some cases you may have to coordinate the directional boring with a plumber and an excavator.

**Brothers Underground:** Brothers Underground seems like a qualified contractor. Apples to apples, their quote to me was over double the quote from J. P. Schmitz. They are currently scheduling work a few weeks out. They do include the cost of the meter in their quote, but all other fees are extra.

**Twin City Sewer & Water:** Twin City Sewer told me their equipment is limited to a 50-foot horizontal run. So, I was not able to consider them. They have hooked up one house on the Peninsula.

**Other:** Here are contractors that may be able to do installs. I don't have any information on them except to say in some cases you may have to coordinate the directional boring with a plumber and an excavator.

So, for me, based upon what I know now and my timeline, J.P. Schmitz is the best choice for price, communications and scheduling. But every property and situation are different. So, verify all information with your contractor.



And once you choose a contractor, there is a process to follow to get permits (including the ML "Right of Way Permit") a water meter and coordinating street use rules and access. (Perhaps another article to cover these points.)
