

**ORDINANCE NO. 10**  
**REGULATING HEALTH AND SANITATION IN THE**  
**VILLAGE OF FRIENDSHIP, ADAMS COUNTY, WISCONSIN**

**SECTION 10-1. Board of Health. [Amended 1-3-2022]**

- 1) How Constituted. The Village of Friendship elects to have the Adams County Board of Health serve as the Village Board of Health. Any references in this chapter to the Board of Health shall be deemed to be references to the Adams County Board of Health.
- 2) Duties. It shall be the duty of the Board of Health to assume the general administration of health laws and regulations and to attend to the administration and enforcement of the health laws of the state and the rules and regulations prescribed by the State Board of Health.
- 3) Powers. The Board shall take such measures and make such rules and regulations as shall be necessary and effectual for the preservation and promotion of the public health in the Village.

**SECTION 10-2. Health Officer. [Amended 1-3-2022]**

- 1) Appointment. The Health Officer of Adams County functions as the health officer for the Village. The Health Officer shall be appointed by the Board of Health pursuant to § 251.06(4)(c), Wis. Stats. The Health Officer shall meet the requirements of § 251.06, Wis. Stats.
- 2) General Duties. The Health Officer under the supervision of the district State Health Officer shall perform the duties required by § 251.06(3), Wis. Stats.

**SECTION 10-3. Compulsory Connection to Village Sewer and Water System. [Amended 1-3-2022]**

- 1) Whenever public sewer or water service has become available to any building used for human habitation or human occupancy, the Village Board shall notify in writing the owner, agent or occupant thereof to connect such facilities thereto. If such person to whom the notice has been given shall fail to comply for more than 90 days after notice, the Village Board shall cause the necessary connections to be made and the expenses thereof to be assessed as a special tax against the property pursuant to § 281.45, Wis. Stats.
- 2) The Village Board may extend the time for connection hereunder or may grant other temporary relief where strict enforcement would work an unnecessary hardship without corresponding public or private benefit.
- 3) This section is enacted pursuant to § 281.45, Wis. Stats.

**SECTION 10-4. Keeping of Animals or Fowl.**

- 1) Sanitary Requirements. All structures, pens, buildings, stables, coops or yards wherein animals or fowl are kept shall be maintained in a clean and sanitary condition, free of rodents, vermin and objectionable odors.

- 2) Animals excluded from food-handling establishments. No person shall take or permit to remain any dog, cat or other live animal on or upon any premises where food is sold, offered for sale or processed for consumption by the general public.
- 3) Possession of Animals. No person shall be allowed to have in his or her possession or keep any horses, cows, sheep, pigs or other domestic animals or over twenty-five (25) chickens or other fowl in the Village of Friendship, except bona fide beef and dairy farms.

**SECTION 10-5. Food and Restaurant Regulations. [Amended 1-3-2022]**

- 1) Displayed food and dairy products. The provisions of the Wisconsin Administrative Code Ch. ATCP 75.06 relating to handling, display and storage of food are hereby adopted by reference and incorporated in this chapter as if fully set forth herein.
- 2) Restaurant regulations. The provisions of Chapter 254, Wis. Stats., and Wis. Admin. Code § DHS 196 relating to the operation and sanitation of restaurants are hereby adopted by reference and incorporated in this chapter as if fully set forth herein.

**SECTION 10-6. Garbage Removal**


- 1) All residents of the Village of Friendship that desire to have garbage removed by said Village shall place all garbage in suitable containers at the curb line of their respective property unless otherwise specified by the Director of Public Works and no container to be removed shall have a volume larger than 30 gallons nor shall any container or item to be removed weigh in excess of 75 pounds so that the same can be adequately handled by one individual. All papers and loose items shall be properly tied. .

**SECTION 10-7. Penalty. [Amended 1-3-2022]**

- 1) Any person who shall violate any provision of this chapter shall, upon conviction thereof, forfeit not less than \$1.00 and not more than \$200.00, together with the costs of prosecution, provided no person shall forfeit an amount in excess of the maximum fine or forfeiture allowed in the Wisconsin Statutes for the same offense, where applicable.

**SECTION 10-8. Effective Date.** This ordinance shall take effect and be in force from and after its passage and publication.
