

VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be **REGISTERED** and provide proof of identification prior to receiving an absentee ballot.

Making application to receive an absentee ballot by mail.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the election. Your written request can be by mail, email, online at MyVote.wi.gov, or in person but must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, your signature and a copy of your photo identification. The **DEADLINE for making application to receive an absentee ballot by mail is 5:00 p.m., on Thursday, March 28, 2024.**

*Voters who are indefinitely confined due to age, illness, infirmity, or disability may not be required to provide photo ID. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

**Special absentee voting application provisions apply to electors who are indefinitely confined, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

The **first day to vote an absentee ballot in the municipal clerk's office is: Tuesday, March 19, 2024.**

Last day to vote an absentee ballot in the clerk's office is: Sunday, March 31, 2024. Final date set by municipality, in person absentee voting can end before this date.

No in-person absentee voting may occur on the day before the election. The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on April 2, 2024. Any ballots received after the polls close will not be counted.
