

TOWN OF QUINCY
ORDINANCE #2024-07 - TEMPORARY SNOWMOBILE ACCESS

**AN ORDINANCE TO ALLOW SNOWMOBILES TEMPORARY ACCESS TO THE
SNOWMOBILE ROUTE/TRAILS IN THE TOWN OF QUINCY, ADAMS COUNTY, WISCONSIN,
FROM THE OPENING OF TRAILS IN 2024 TO THE CLOSE OF TRAILS IN MARCH OF 2025.**

The Town Board of Quincy ordains as follows:

SECTION I. Intent:

The Intent of this ordinance is to provide a temporary means for persons to travel:
Deerborn Drive from East Quincy (town line to County Road Z)
French Street from Walnut Grove Storage to Hill Street
Hill Street from French Street to Maple Street
Maple Street from Hill Street to Linehan Avenue
Linehan Avenue from Maple Street to County Road Z
Dover Drive from Town Road to East End
18th Avenue from Dover Drive to Dyke Avenue
Dyke Avenue from 18th Avenue to County Road Z

The temporary route is for the period of the opening of trails in 2024 to the close of trails in March of 2025.

SECTION II. Statutory Authority:

This Ordinance is adopted as authorized under Wisconsin Statutes 350.18(3)(a).

SECTION III. Designated Roadways and/or Highways:

No person shall operate a snowmobile on a roadway or on the shoulder of a highway not designated as a snowmobile route except for access.

SECTION IV. Speed:

A snowmobile operated on the portions of the road(s) described in Section I shall observe roadway speed limits.

SECTION V. Enforcement:

This Ordinance shall be enforced by any law enforcement officer.

SECTION VI. Penalties:

Wisconsin State Snowmobile penalties as found in Wisconsin Statutes 350.11(1)(a), are adopted as reference.


SECTION VII. Effective Date:

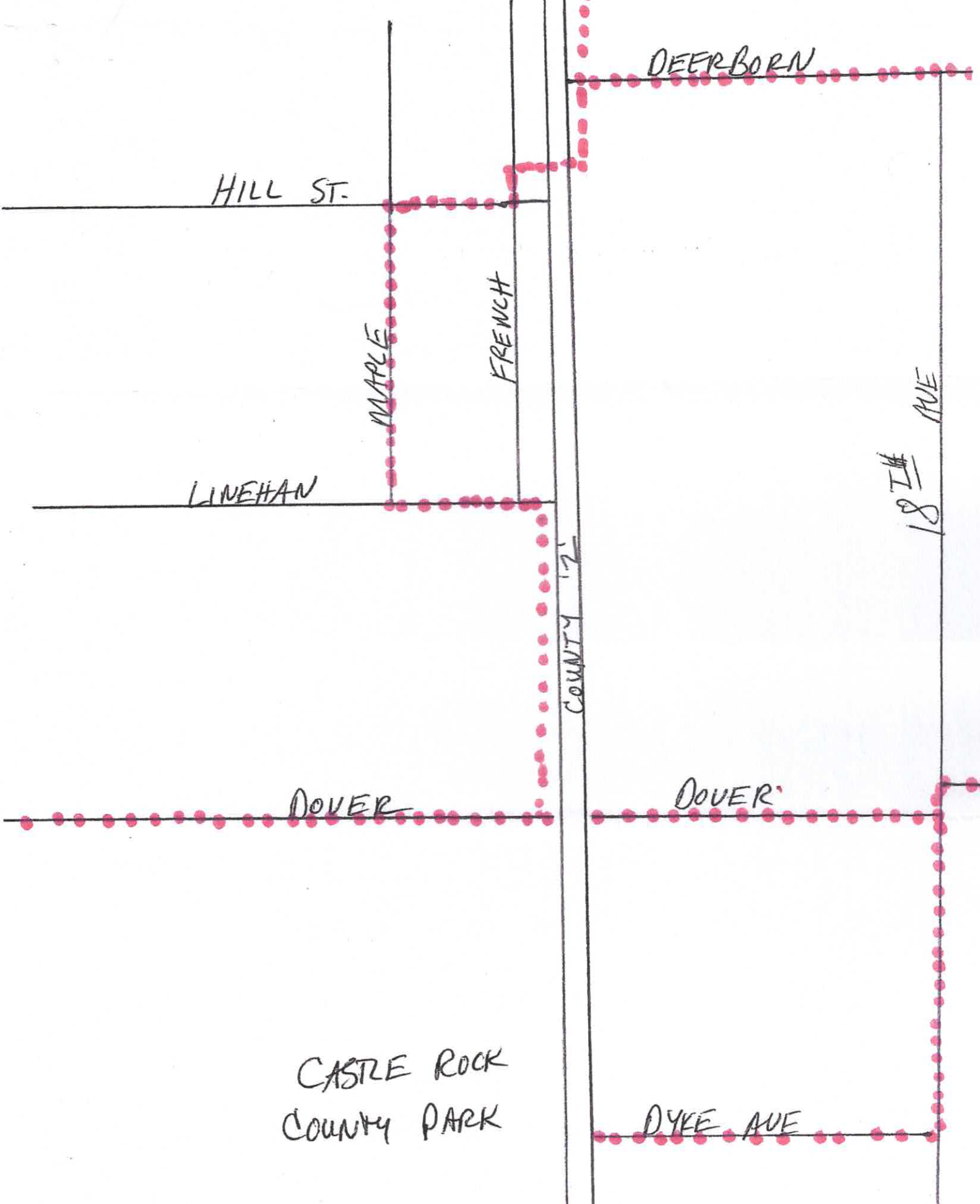
