

**Resolution #2024-14** Resolution Adopting the Tentative Budget for Fairfield Town for the fiscal year 2024-2025; setting a date, time, and place for a public hearing and adoption of the fiscal year 2024-2025 budget; and ordering that notice of the public hearing be published at least seven days in advance.

**Dated June 12, 2024**

**WHEREAS**, Section 10-6-111, Utah Code Annotated, 1953, as amended, requires that the Budget Officer, on or before the first regularly scheduled meeting in June, to present to the Town Council for consideration a tentative budget for the next fiscal year; and

**WHEREAS**, Section 10-6-113, Utah Code Annotated, 1953, as amended, requires that a public hearing should be scheduled to obtain public comment prior to the final budget adoption; and

**WHEREAS**, Section 10-6-113, Utah Code Annotated, 1953, as amended, requires that the Town Council establish the date, time, and place of a public hearing to consider its adoption and to order that notice of the public hearing be published at least seven days prior to the hearing in at least one issue of a newspaper of general circulation published in the county in which the city is located, and on the Utah Public Notice Website.

**NOW THEREFORE**, be it resolved by the Governing Body of the Fairfield Town, Utah, that:

1. The Fairfield Town Council does hereby adopt the tentative budget for the fiscal year 2024-2025 as set forth and attached hereto.
2. A public hearing is hereby scheduled for Wednesday, June 26, 2024, at 7:00 pm at the Fairfield Town Hall at 103 East Main Street, in Fairfield, Utah, for the purpose of receiving public comment and input on the tentative municipal budget for the fiscal year 2024-2025.
3. The Town Council orders that notice of the public hearings be published at least seven days prior to June 26, 2024, on the Town website and on the Utah Public Notice Website.

**BE IT FURTHER RESOLVED** that this resolution shall take effect immediately upon passage.
