

**Resolution No. R2024-25** A Resolution Of Fairfield Town, Utah, Consenting To The Transfer Of Title To Property Located In The Boundary Of The Interlocal Of The New School District In West Utah County.

### Preamble

**WHEREAS**, in the 2024 General Election, voters approved a proposal to create a new school district; and

**WHEREAS**, Alpine School District wishes to sell Utah County Parcel 59:042:0008, located within the boundaries of the new school district, as it is in the direct path of a proposed new highway; and

**WHEREAS**, Utah Code Annotated 53G-3-302(6) states that a divided school district may not transfer or agree to transfer title to district property beginning on the day the new school district is created, without the prior consent of the legislative bodies of all interlocal agreement participants in which the boundaries of the new school district are located; and

**WHEREAS**, the Town Council of Fairfield Town, Utah, finds it is in the public interest to consent to the sale of Utah County Parcel 59:042:0008, to allow Alpine School District to purchase a new parcel in the same area which is not affected by a future highway.

**NOW THEREFORE, BE IT RESOLVED** by the Town Council of Fairfield Town, Utah:

1. The Town Council of Fairfield Town, Utah, consents to the sale of Utah County Parcel 59:042:0008.
2. This Resolution shall become effective immediately upon its passing. ADOPTED by the Town Council of Fairfield Town, Utah, this **18th day of December, 2024**.
