Utility Placement Standards See Title 6.3 Roads

- 1. Any site must be marked by Blue Stakes of Utah prior to digging.
- 2. Any person owning, managing, or operating any of the above utilities within, under, along, over or across a Fairfield highway or right-of-way shall bear the expense of replacing all damaged materials and areas, including asphalt, fill, gravel, or any other material that was

disturbed in the process.

- 3. Any person owning, managing, or operating a utility within, under, along, over, or across a Fairfield Town road, highway, or right-of-way shall hereinafter have full responsibility for the repair, replacement, or relocation of the utility where the utility is damaged or a relocation is needed as a result of a rebuilding, reconstruction or realignment of a Fairfield Town road, highway or right-of-way. Within five days after notice from Fairfield Town, the person owning, managing, or operating such utility shall make all the necessary repairs and relocations at his own expense. If the person fails to do so, Fairfield Town may have the work done, and the person shall be obligated to pay for it. Boring of pipelines under the roads is encouraged. The applicable cost of an extension shall include the replacement of all road surfaces damaged or removed for installation of new extensions in accordance with the *National Design Guidelines* and *Standard Specifications of the American Public Works Association (APWA)*.
- 4. No material, plan modification, or use variation from the approved plan shall be allowed unless such variations shall first have been approved in writing by the Roads Department or designee.
- 5. All permit fees shall be set by a resolution adopted by the Town Council. (see FF Fee Schedule)
