



Resolution No. R2026-15 A Resolution Approving the Transfer of Fairfield Depository Accounts to Mountain America Credit Union.
Date July 7, 2026

WHEREAS, Fairfield maintains public funds in depository accounts for the conduct of Town business and the safekeeping of public funds; and

WHEREAS, Utah Code § 10-5-128 requires the Town Treasurer to promptly deposit all Town funds in the appropriate accounts of the Town; and

WHEREAS, the Fairfield Town Council has reviewed the Town's current banking relationship and finds it to be in the best interest of the Town to transfer its depository accounts from Alta Bank to Mountain America Credit Union; and

WHEREAS, the Fairfield Town Council finds that Mountain America Credit Union is qualified and authorized to receive public funds in accordance with applicable Utah law; and

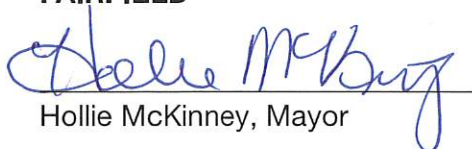
WHEREAS, the Fairfield Town Council finds it necessary and appropriate to authorize designated Town officials to establish, administer, and maintain Town accounts with Mountain America Credit Union and to complete all actions necessary to transfer Town funds and banking services;

NOW, THEREFORE, BE IT RESOLVED that Fairfield hereby approves the transfer of Town depository accounts and banking services from Alta Bank to Mountain America Credit Union, and authorizes the Mayor, Treasurer, Recorder, and any other duly authorized Town officials to execute all documents and take all actions necessary to implement the transfer.

EFFECTIVE DATE: This Resolution shall become effective immediately upon adoption.

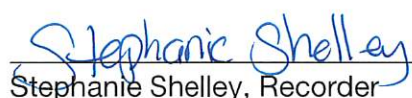
