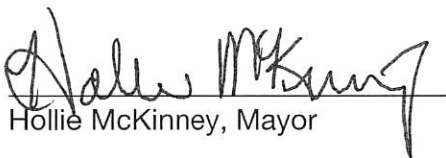
WHEREAS, the Fairfield Town Council has reviewed the proposed changes; and
