All parties determined to be Vendors by Event Officials must be registered to participate in these events and agree to abide by all terms. Vendors must provide proof of insurance. Food vendors must possess and display current SC DHEC certificate. Operations must be self-contained. Water and Power are not provided. Trash and litter must be adequately contained at all times. Excessive and/or household trash will be removed by responsible vendors. No dogs on site. All vehicles must be removed from event areas to parking in designated areas only. No illegal, illicit, mature content, or unapproved club-related paraphernalia is to be displayed, distributed and/or sold at Chesnee City Events. Sales, operations and/or disruptive activity is not allowed on event grounds between 10PM and 8AM. Only officially-approved music and/or announcements, amplified or not, are allowed. Use of remote devices including aerial drones at any time requires prior registration with Events Officials, proof of insurance and permission to proceed. **Terms are subject to change at any time without notice. All decisions by Event Officials are Final.** Please help keep these great events safe, fun, and family friendly.
