Any person wishing to file as a candidate must be a Spartanburg County registered voter and a resident of the municipality/SPD for at least 30 days prior to the election.

Filing Form: The Nonpartisan Statement of Intention of Candidacy form is available at the County Registration and Elections Office or from the candidate section of the following website: www.scvotes.gov.

Filing Fee: Filing fees must be paid to the City/Town Clerk of the respective municipality and a receipt attached to the Statement of Intention of Candidacy form. The County Registration and Elections Office does not accept payment for any fees.

State Ethics Filings: Candidates are required to file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission at ethics.sc.gov. Failure to file these documents may results in a candidate fine but will not disqualify a candidate from the election.
