All Parties Must Check in with Event Officials BEFORE Set-Up.



Excessive and/or household trash will be removed by responsible vendors. All vehicles must be removed from event areas to parking in designated areas only. No illegal, illicit, mature content, or unapproved club-related paraphernalia is to be displayed, distributed and/or sold at Chesnee City Events. Only officially-approved music and/or announcements, amplified or not, are allowed. Use of remote devices including aerial drones at any time requires prior registration with Events Officials, proof of insurance and permission to proceed. Terms are subject to change at any time without notice. All decisions by Event Officials are Final. Please help keep these events safe, fun, and family friendly.
