

**RE: Dane County Zoning & Land Regulation (ZLR) Public Hearing for CUP #2496 POSTPONED**

Dear Resident,

**The county public hearing for CUP #2496 scheduled for July 28<sup>th</sup> is being postponed to a later date.**

The Covid-19 pandemic has created many frustrating circumstances that have affected all aspects of our world. Unfortunately, zoning is not exempt. The county has adapted by holding virtual public meetings that allow for participation by phone, computer, or smartphone app. While this method of conducting public meetings has its advantages, some believe it cannot completely capture many of the nuances of an in-person meeting. Rutland Town Chair Peter Loughrin has expressed this concern to the County and requested that the ZLR Committee postpone the Dane County public hearing for CUP 2496 scheduled for July 28<sup>th</sup>.
