## TOWN OF RUTLAND ORDINANCE NO. 85-02

AN ORDINANCE ESTABLSIHING JURISDICTION AND DUTIES OF TOWN CONSTABLES

THE TOWN BOARD OF SUPERVISORS OF THE TOWN OF RUTLAND DOES ORDAIN:

- 1. That Ordinance No. 85-1, adopted January 8, 1985, be and is hereby repealed, and
- 2. That Ordinance No. 85-02, entitled "Ordinance Establishing Jurisdiction and Duties of Town Constables" be and the same hereby created to read as follows:

WHEREAS, effective January 1, 1985, pursuant to 1983 Wis. Act 532, Sec. 60.22(4) the Town Board shall determine the jurisdiction and duties of the Town Constables, and

WHEREAS, it is in the public interest and welfare to establish the jurisdiction and duties of the constables of the Town of Rutland, as provided herein.

NOW, THEREFORE, the Town Board of Supervisors of the Town of Rutland, Dane County, does ordain as follows:

## SECTION 1 STATUTORY AUTHORITY:

Pursuant to Sec. 60.22(4) and Sec. 60.35 of the 1983 Wisconsin Act 532, the Town Board of Supervisors of the Town of Rutland, Dane County hereby establishes the jurisdiction and duties of the Town Constables of the Town of Rutland, Dane County as described herein.

## SECTION 2 JURISDICTION AND DUTIES:

The Town constable of the Town of Rutland, Dane County, shall:

- (1) Suppress unlawful assemblies within the Town of Rutland pursuant to Sec. 947.06 of Wisconsin Statutes.
  - (2) Inform the Dane County Sheriff of all tresspasses.
- (3) Cause to be enforced and report all violations of Town Ordinances of which he has knowledge or information to the Town Board of Supervisors.
  - (4) Act on behalf of the Town Board as directed.

## SECTION 3 NONEXCLUSIVITY

## A. OTHER ORDINANCES

Adoption of this ordinance does not preclude the Town Board from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter.

## B. OTHER REMEDIES

The jurisdiction and duties of the Town Constable(s) as stated herein shall not preclude the Town Board or any other town officer from proceeding under any ordinance or law or by any other enforcement method to enforce any ordinance or order.

# SECTION 4 SEVERABILITY

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any spersonor circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.
