Project to rebuild the Town of Rutland Garage/Town Hall

Project cost: \$2,206,633

Borrowing required: \$1,956,000 at 6.25% for 20 years

Annual budgeted payment: \$175,564

Property tax impact: Per \$100,000 of assessed property value: \$44.20 annually or \$3.68 monthly

QUESTIONS:

Why now?

There is never a "best" time for any project like this. The Committee reviewed the past project and other similar, nearby Towns. It is clear that building costs will continue to escalate and the best time to do this was 10 years ago. It is time!

Aren't interest rates too high?

The Town can obtain financing at 6.25%. While this is higher than the low rates we used to have, it is not unreasonable. If rates do drop in the future, the Town can refinance and take advantage of that.

Is this really necessary?

The Town patrolmen maintain our roads, keep them clear of ice, snow and falling trees. Our trucks only fit inside when the plows are removed, meaning they have to be put back on, outside, every time they're used! Other equipment gets squeezed in or left outside. The inside meeting area is shared with the garage, residents don't like the diesel exhaust, drafts, insects, rodents and awful acoustics when attending Town meetings or voting. Critical Town paper records are stored in official's homes, in the back room, subject to humidity, fire and other possible loss.
