

## Dog License Information

### Rabies vaccination and dog licenses are require under state statutes

**Wis. Stats. 174.042(4):** If the owner of a dog negligently or otherwise permits the dog to run at large off premises or be untagged, the owner shall forfeit no less than \$25.00 nor more than \$100.00 for the first offense and not less than \$50.00 nor more than \$200.00 for the subsequent offenses. **Wis. Stats. 95.21(2)** requires that all dogs be vaccinated for rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination and every 3 years thereafter.

#### Dear Town of Apple River Resident,

WI State Statute 174.05 requires dog(s) more than 5 months old be licensed each year. A license year is from January 1st to December 31st and must be renewed annually. Please complete the application below and return on or before January 31<sup>st</sup>. A \$5.00 penalty is charged for each dog after April 1<sup>st</sup>. Make one check for all dog licenses. If you are paying for dog licenses and taxes at the same time, two separate checks are needed.

**Landlords:** It is your responsibility to notify your tenants of this requirement. All dogs must be licensed and vaccinated.

A \$5.00 penalty will be assessed after April 1<sup>st</sup> for each unlicensed dog. The delinquent dog owners list will be turned over to the District Attorney for collection. You need to fill out an Affidavit of Death or Disposal of Dog Certificate for any dog that was sold, given away, or has died since the previous year.
