The rand is trading at R17.85 down 1 cent from last week. Volatility in the rand is picking up as the market tries to digest the impact that the US tariffs are likely to have on an already fragile economy. The rand has pulled back in the last 2 days after reaching a high of R18.35 on Friday. The initial weakening has been offset following weaker than expected labor numbers coming out in the US. The US economy only added 73000 jobs in July with an expected number of 110 000. June was also revised downwards to 14000 versus 147000 initially stated. The market is now pricing in a 90% chance of a rate cut in September, with 63 basis point cuts planned till the end of the year.

Soya bean meal:

Soya bean meal for Sep 2025 is currently trading at 277.7 dollars per short ton, 4.01% higher in the last week with forward contracts also higher. Soya beans are down by 1.46% on the nearby, with forward contracts also lower. Soya oil is sharply down by 5.94% on the nearby, with forward contracts also sharply lower on the back of a steep drop in oil prices. The market continues to monitor the trade negotiations between the US and China with US President Donald Trump stating a trade deal is close to being reached, and that he will meet the Chinese Premier towards the end of the year if an agreement is reached. The market is trying to position itself for a possible deal which it hopes will spur on demand but is however hampered by ample supply and favorable growing conditions in the US. 69% of the US soya bean crop rated good/excellent down 1% from last week and up 1% from last year.





Midwest:

Warmer temperatures expected this week after a mild weekend with Canadian wildfire smoke. Spotty showers mid-week, followed by a stronger front bringing scattered showers and cooler temps by the weekend. Soil moisture supports corn and soybean growth.

Southern Plains:

Temperatures rising above average later this week. Northern fronts bring rain to Nebraska, but Southern Plains stay drier. Recent rainfall keeps corn and soybean conditions favourable.

Northern Plains:

Scattered showers continue this week, boosting soil moisture for corn and soybeans but less ideal for maturing wheat. Heavy rain may affect wheat quality.

Delta:

Heavy rain from a stalled Gulf coast front, mostly coastal this week. Drier northern areas aid maturing crops, but prolonged dryness could stress crops.


Pacific Northwest:

Isolated showers after a hot spell stressing spring wheat. Temperatures briefly cool mid-week but trend warmer by the weekend, with rain favouring northern areas.

Brazil:

Lingering front brings rain, with more expected late this week, potentially disrupting corn harvest but aiding winter wheat. Drier conditions may follow.
