ANIMAL WELFARE POLICY



INHUMANE TREATMENT OR ABUSE OF AN ANIMAL, IN ANY MANNER, IN THE ARENA OR ON THE GROUNDS IS PROHIBITED.

INHUMANE TREATMENT INCLUDES THE RIDING OF A CRIPPLED, LAME OR INJURED ANIMAL OR AN ANIMAL WITH ANY HEALTH ABNORMALITY WHICH COULD RESULT IN THAT ANIMAL'S UNDUE SUFFERING OR DISTRESS.

ANY ACT OF ABUSE, OR INTENT TO ABUSE AN ANIMAL IN THE ARENA OR THE GROUNDS WHICH COULD ENDANGER THE SAFETY OF OTHER PERSONS OR ANIMALS WILL BE DEALT WITH IN THE STRONGEST POSSIBLE MANNER AS PROVIDED BY THE ABCRA RULES.

IF THE ORGANISING COMMITTEE AT ANY ABCRA APPROVED OR AFFILIATED EVENT DISCOVERS INHUMANE TREATEMENT OR ABUSE OF LIVESTOCK, IT MAY IMMEDIATELY EXPEL THE RESPONSIBLE PARTY FROM THE GROUNDS & ANY FURTHER PARTICIPATION IN THE EVENT.


