

LEVELS OF ATTAINMENT

The following information indicates the proficiency required to become an AQHA Judge and for current Judges who must complete a Refresher Exam annually. All Judges exams are now ONLINE.

ASSOCIATE JUDGE

Theory Exam	The applicant must be able to obtain a minimum overall score of 80%
Video Judging	The applicant must be able to: A. Correctly identify, a minimum of 80% of the 1 st and last placed horses in each class. B. Correctly identify the order of the placegetters; at least 75% of the time. C. Correctly identify all major penalties in the scored classes; at least 80% of the time
Co-Judging Assignments	The applicant must be able to, at all 3 shows: A. Correctly identify, a minimum of 80% of the 1 st and last placed horses in each class. B. Correctly identify the order of the placegetters; at least 75% of the time. C. Correctly identify all major penalties in the scored classes; at least 80% of the time
