If your show application is approved, you will receive an approval letter from the AQHA. Upon approval of your show application, an official approval letter will be issued by the AQHA. This approval may be revoked if any alterations are made to the approved date, venue and / or program.

Show Results, any Accident Reports and Complaint Reports must be returned to AQHA in such time that they will be postmarked no later than 14 days after the closing day of the show
